



Privacy Policy for RWA (Real World Assets) Crypto Exchange

At RWA, the Real World Assets Crypto Exchange, owned by IPDAO, we are committed to protecting the privacy and security of your personal information. This Privacy Policy (the "Policy") explains how we collect, use, disclose, and protect your information when you use our platform. By accessing or using RWA, you consent to the collection, use, disclosure, and processing of your information as described in this Policy.

1. Information We Collect

- **Personal Information:** When you register for an account on RWA, we may collect personal information such as your name, email address, date of birth, and government-issued identification documents.
- **Financial Information:** We may collect financial information, including bank account details and cryptocurrency wallet addresses, to facilitate transactions on RWA.

We implement technical and organizational measures to protect your information against unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is 100% secure, and we cannot guarantee absolute security.

5. Your Rights



You have the right to access, update, and correct your personal information stored on RWA. You may also request the deletion of your account and associated information, subject to legal and regulatory requirements.

6. Cookies and Tracking Technologies

We use cookies and similar tracking technologies to enhance your experience on RWA and to collect information about your usage patterns. You can adjust your browser settings to refuse cookies or to alert you when cookies are being sent, but this may affect the functionality of RWA.

7. Children's Privacy

RWA is not intended for use by individuals under the age of 18. We do not knowingly collect personal information from children under the age of 18.

8. Changes to this Policy

We may update this Policy from time to time by posting the revised version on RWA. Your continued use of RWA after any such changes constitutes your acceptance of the updated Policy.
